The annual meeting of the Town of Concord was called to order at 7:00 p.m. by the Chairman, Dale Konle with Supervisor Bill Ingersoll, Supervisor Lloyd Zastrow, Clerk Brian Neumann and Treasurer Jim Zastrow present. Dale led the assembly in the Pledge of Allegiance and Brian certified that the meeting has been properly posted.

Clerk Brian Neumann read the minutes from the April 21, 2020 annual meeting. Bill Ingersoll moved to approve the minutes as read, seconded by Dale Konle and carried by voice vote.

Treasurer Jim Zastrow reviewed the income portion of our Profit Loss report stating we received \$750,808.15 on a budget of \$614,917.34 The town received \$135,890.91 more than budgeted. This was driven by the ARPA funds of \$111K and \$9K Sale of equipment.

Clerk, Brian Neumann reviewed the disbursements classified portion of the Profit & Loss statement. We spent \$636,396.28 on a budget of \$614,917.34 or \$21,478.94 over budget. This was driven by the purchase of a new lawn mower and Bobcat. This was offset by the sale of highway equipment.

Brian read Tom Mark's Building Inspector report. There were 34 building permits, 48 electrical permits, 10 plumbing permits and 23 heating permits. We also had 2 new single-family homes, 0 new mobile homes and 32 misc. permits.

Cindy Arbiture moved to petition Jefferson County for \$5,068.00 in road aid, seconded by Tom Williams and carried by voice vote.

Sally Williams moved to retain the ISB Community Bank as the town's depository, seconded by Pat Brandt and carried by voice vote.

Bill noted the town picnic is on August 14, 2022 and the mood of the assembly is to continue the picnic tradition.

Dale noted that the next annual meeting will be held on April 18, 2022.

With no further business, Sally Williams moved to adjourn, seconded by Tom Williams and carried by voice vote.
